**RESOLUTION
OF THE BOARD OF DIRECTORS OF VINACOMIN – MINERALS
HOLDING CORPORATION**

Pursuant to the Charter on the Organization and Operation of Vinacomin – Minerals Holding Corporation (7th Amendment), issued together with Decision No. 628/QD-VIMICO dated 5 May 2026 of the Board of Directors of Vinacomin – Minerals Holding Corporation;

Pursuant to the Minutes of the Board of Directors' Meeting No. 2675/BB-VIMICO of the Board of Directors of Vinacomin – Minerals Holding Corporation dated 28 September 2026,

HEREBY RESOLVES:

Article 1. The Board of Directors of Vinacomin – Minerals Holding Corporation unanimously approves the following specific matters:

I. To approve the transaction whereby Vinacomin – Minerals Holding Corporation outsources the intermediate overhaul of Excavator EKG-5A No. 16 to Vinacomin – Machinery Joint Stock Company, with the following key terms:

1. Service package: "Intermediate Overhaul of Excavator EKG-5A No. 16".
2. Package value: VND 3,755,162,990.
4. Funding source: Production costs of the Corporation's parent company.
5. Contract duration: Up to 70 days from the date of signing of the Equipment Handover Record for repair.
6. Contract type: Fixed unit price.

II. To approve the transaction whereby Vinacomin – Minerals Holding Corporation outsources the intermediate overhaul of Komatsu Excavator PC1250 No. 22 to Vinacomin – Machinery Joint Stock Company, with the following key terms:

1. Service package: "Intermediate Overhaul of Komatsu Excavator PC1250 No. 22".
2. Contract value: VND 3,913,948,845.
4. Funding source: Production costs of the Corporation's parent company.
5. Contract implementation period: Up to 60 days from the date of signing of the Equipment Handover Record for repair.
6. Contract type: Fixed unit price.

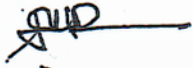


Based on this Resolution, the General Director shall organize implementation in accordance with applicable regulations.

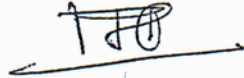
